IG's durability is warranted for 20 years from the day of purchase. In the event an IG component fails to remain intact due to a material defect, we will either send you replacement material or refund your money upon receipt of the defective components.

This warranty is transferable. It may be transferred from the original owner to the next owner, provided InvisiGuard, a Division of Swistun, Inc. receives written notice within 45 days of the date of the real estate title transfer. Notice must include the original owner's name as shown on the warranty certificate, the name of new owner, and both of their signatures.

This warranty is subject to the following terms:

1. IG must be installed according to InvisiGuard™ installation requirements.
2. The following conditions are not covered under this warranty and may void this warranty:
  - a. Damage caused by falling branches, trees, ladders, fire, lightning, windstorms, hailstorms, any acts of God, vandalism, the appearance of vandalism, or any thrown object.
  - b. Damage caused by roof equipment, foot traffic, loose/blown shingles, and other exterior structural components.
3. Your warranty coverage schedule is as following and begins on the date of your original installation:
